Action Clerk and Clr Page to ask Barclays for a fixed term interest account. Proposed to transfer £280,000 into savings account by Clr S Keller and seconded by Clr Cooper.

Ring fenced allotment amount to be transferred to fixed term deposit account once set up.

To be ratified at Full Council.
